8	Any person aggrieved with the decision of the Commission may appeal to the Regulator	Friday 7 th August, 2026
9	The REGULATOR will decide the case whose decision in this regard shall be final	Saturday 15 th August, 2026

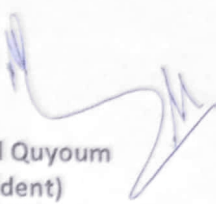

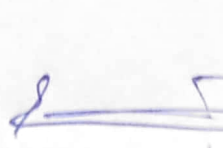
Explanation:
